Notes on Submitting the Form

1. Accepted manuscripts for the *American Journal of Occupational Therapy* and other American Occupational Therapy Association (AOTA)/AOTA Press publications cannot be published unless the Copyright Transfer/Author Certification/Financial Disclosure Form is completed, signed, and returned.
2. The signed form should be submitted with the manuscript.
3. The signed form should be scanned to pdf and uploaded to the AJOT manuscript submission system (<https://ajot.submit2aota.org/>) as a separate file.
4. It is not necessary to submit original signed hard copies. Authors should keep the original documents with their records, however.
5. Manuscripts cannot be reviewed until the Copyright Transfer/Author Certification/Financial Disclosure Form is completed, signed, and submitted via <https://ajot.submit2aota.org/>.

Notes on Completing the Form

1. Section 1A: Copyright Transfer
 - *Only the corresponding author is required to sign this section.* By signing, the corresponding author affirms that he or she is authorized to sign this form on behalf of all authors.
2. Section 1B: Work for Hire
 - In addition to the author signature in Section 1A, authors whose work was performed (i.e., who wrote the manuscript) within the scope of their employment must provide the signature of an authorized representative of the employer.
3. Section 1C: U.S. Government Employees:
 - Instead of the author signature as required in Section 1A, author(s) whose work was performed (i.e., who wrote the manuscript) within the scope of their employment with the U.S. Government must provide the signature of an authorized representative certifying that the work is in the public domain.
